# TERMS & CONDITIONS OF MEMBERSHIP

## 1. Membership Applications:

1.1 Persons wishing to become members of the Facility shall be residents of the Town of Ramapo, and complete the Application Form and submit it to the membership desk. The Town of Ramapo reserves the right to reject any application for membership without giving any reason for so doing. By signing the Membership Application Form the member agrees to comply with these Terms and Conditions of Membership and the Facility Rules.

## 2. Suspension of Membership/Relocation Refunds:

2.1 There are no membership refunds.

2.2 A Member may, if he/she is unable to make use of the facilities by reason of illness or injury, suspend his/her membership for one continuous period of at least 1 month, written notice must be given by a physician. Extended illnesses and/or injuries will be reviewed on a case by case basis for credits and refunds. The period of suspension for the member affected will be added to the year membership, therefore extending the renewal date accordingly.

2.3 If you and/or your family is moving out of the Town of Ramapo, a pro-rated refund will be given once proof of new residency is received with a letter requesting a refund.

## 3. Termination of Membership:

The Town of Ramapo reserves the right to terminate membership:

3.1 Without notice in the event of repeated or serious breach of the Center Rules or the Membership Terms and Conditions.

3.2 On at least 7 days' notice in writing, in the event of any other breach of the Center Rules or the Membership Terms and Conditions, including, but not limited to, the non-payment of any fees owing to the Town of Ramapo within 14 days of their due date.

## 4. Membership Card:

4.1 Membership cards shall be issued to all members upon joining and are to be used to gain entry to the Center. Membership cards are not transferable and any members allowing their card to be used by another person is in serious breach of these Membership Terms and Conditions and will entitle the Town of Ramapo to terminate membership without notice in accordance with Clause 6 above.

4.2 If a membership card is lost, it should be reported to the Town of Ramapo who reserves the right to charge an administration fee for the provision of a replacement membership card.

## 5. Center Rules:

The Town of Ramapo may amend the Rules from time to time in order to ensure the health and safety of members. Temporary amendments will be displayed in the reception area. Permanent changes to the Rules will only be made after at least 30 days notice to members, except in the case of emergency.

## 6. Conduct:

6.1 Members must wear appropriate clothing and shoes in the Center, black soled shoes will not be allowed in gyms, racquetball courts or dance studio.

6.2 Members must not:

6.2.1 Abuse the equipment or facilities of the Center. Any willful, negligent or deliberate damage to Center property must be paid for.

6.2.2 Behave in a disorderly, violent or rude manner or in a manner which causes or is likely to cause offense or distress to other members or staff of the Center.

6.2.3 Smoke in the Center.

6.2.4 Bring or consume alcohol or drugs in the Center.

6.2.5 Use the facilities while under the influence of alcohol or drugs.

## 7. Restriction of Liability:

7.1 The Town of Ramapo will not accept liability for any loss, damage to or theft of money, valuables or other personal property of members and guests. Property stored in lockers provided by the Center is stored at the owner's risk and no liability for loss or damage thereto will be accepted by the Town of Ramapo.

7.2 The Town of Ramapo accepts no liability for any damage, accident or injury or other loss sustained by members or guests on the Center premises.

## 8. Physical Activity Readiness Questionnaire:

8.1 Upon joining the center all adult members are required to complete and sign a Physical Activity Readiness Questionnaire. The purpose of this is to ensure that the Facility staff is fully informed of any physical or medical condition which could affect the member's ability or suitability to take part in physical activities. Only if the Facility staff is fully and accurately informed, can they assess the member's health and fitness level and advise on appropriate exercise programs.

8.2 The Town of Ramapo strongly recommends that all members seek medical advice before commencing a new exercise program and reserves the right to request a doctor's certificate and to reject a membership application if a satisfactory doctor's certificate is not received.

## 9. Health & Safety:

Members must read all Health and Safety notices displayed in the Facility and comply with their recommendations.

## 10. Miscellaneous:

10.1 The Town of Ramapo reserves the right to alter the operating off-peak access hours of the facility, provided that the Town of Ramapo shall always attempt to give at least 30 days notice to all members of any permanent change in these hours.

10.2 The Town of Ramapo reserves the right to adjust the availability of certain facilities on a temporary basis for the general purpose of cleaning, decorating, essential repairs, maintenance of equipment, special functions and holidays.
